Minutes of Meeting

In the meeting of the Research & Consultancy Committee held on 08.08.2024 at 3.45 PM in the board room of Samarth Institute of Pharmacy, Belhe, the following decisions were recorded.

Item No. 1) To assign project guides to B. Pharmacy final-year students for their practice school and research work projects.

Resolution - The meeting commenced with the discussion of assigning project guides to final year B.Pharmacy students. Research consultancy committee presented a list of available faculty members with their areas of expertise. Students were given the opportunity to express their project interests based on the faculty expertise. A finalized list of student-guide combination was circulated to all students and faculty and displayed on 10.08.2024.

Item No. 2) To discuss SOP for synopsis submission, presentation & dissertation work.

Resolution: The committee reviewed the Standard Operating Procedure (SOP) for synopsis submission, presentation, and dissertation work. RCC Chairman Dr. Hatapalki B.C. suggested minor revisions to the SOP for clarity on formatting and referencing guidelines. The committee decided to finalize the revised SOP and circulate it to all students for reference. There was suggestion from RCC members that the revised SOP/guidelines should make easy access to all guides. Accordingly, the chairman has directed the RCC coordinator Mr. Gadge S.C. to upload the guidelines on the google drive and provide the link & QR code for the access for the future reference for all guides.

Item No. 3) To discuss on the Research project topic selection and feasibility.

Resolution- The meeting addressed the matter of selecting research topics and ensuring their feasibility. All faculty members were given guidance on factors to consider while selecting a research topic, including:

- Alignment with faculty expertise
- Availability of resources
- Ethical considerations
- Potential impact of the research
- Easy and common availability of API

The meeting also discussed and decided to encourage the students to discuss potential research topics with their assigned project guides for the outcome base research.
